The engaged employee shall be governed under Odisha Government Servant's Conduct Rules, 1959 and are liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Civil Services (Pension) Rules, 1992. All Acts, rules and regulations applicable to a Government employee shall be applicable to them, mutatis mutandis. The appointee will furnish an undertaking at the time of joining the duty in regard to the truth and correctness of the information furnished by him/her.
4. The competent authority reserves the right to disengage without assigning any reason thereof. However, if the Retired employee desires to resign he/she shall do so by giving one month's written notice to the competent authority.
